## Dear Parent or Guardian:

We are pleased to inform you that when school begins this fall for the 2023-2024 school year, Kern High School District students will be provided breakfast and lunch meals at no cost during each school day to students requesting a meal, regardless of their family's income. California has become the first state to pass a Universal Free Meals Program for all public school students that became effective with the 2022-2023 school year, which means students will be allowed to have school meals at no cost.

The Universal Free Meals Program will provide students access to daily breakfast and lunch meals without having to qualify for eligibility based on a family's income; no student will be turned down. It is still important for **ALL** households to complete an Alternative Income form, as this may bring significant additional funds to the district's school sites. The information gathered from these forms is critical in determining the amount of funding our schools receive to provide supplemental resources for our students. After July 1, 2023, and before the start of school you will receive more information in the mail, including the appropriate application form which should be completed for your student. This information will also provide designated weblinks to complete the forms electronically, for your ease and convenience.

We would like to ask your cooperation in completing these forms promptly once received, and before the start of school if possible. Without your assistance, the schools cannot maximize utilization of available state and federal funds. Completion of these forms may also qualify students for individual benefits such as college application waivers, SAT/ACT/AP/IB testing fee waivers, and Pandemic-Electronic Benefits Transfer (P-EBT), in addition to possible discounts for internet, cable, cell phones and other services.
