We are pleased to inform you that Redlands Unified School District (RUSD) will continue the Community Eligibility Provision (CEP) for all RUSD students for school year 2023-24.

Every school day, all students are eligible to receive one healthy breakfast and one lunch at **no cost** for the 2023-24 school year. Your Children will be able to participate in these meal programs without having to pay a fee or submit a meal application.

As part of the Healthy Hunger-Free Kids Act of 2010, RUSD is CEP qualified based on the high enrollment of CalFresh, CalWORKs, Medicaid and the number of students that are foster and homeless. This letter **may** serve as notification to qualify your student(s) for waived fees for school expenses such as AP, SAT, and PSAT testing or waived college application fees. This letter **may** also qualify you for reduced utility rates.
