- fax it to 585-266-1556 Attn: Food Service Office

We will start entering submitted applications on August 7, 2023. They will be entered first by those who apply by income. Those who apply with SNAP or MEDICAID will be entered after August 31, 2023, after we've received and uploaded the most current New York State Direct Certified List.

Our Food Service Office has limited summer hours and will answer questions as soon as possible during our summer hours. Children need healthy meals to learn. West Irondequoit Central School District offers healthy meals every school day. Breakfast will consist of milk, juice, fruit and cereal. Meal costs: breakfast \$1.80; student lunch \$2.95; cost of milk only \$.60. Children from households that meet federal income guidelines (outlined below) are eligible free or reduced-price meals. As of July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge. NOTE: If the student becomes eligible for free or reduced meal benefits, but decides they only want milk for their meal, they will be charged \$.60 per milk. To apply for free or reduced-price meals, submit a Direct Certification letter, including your case number, from the NYS Office of Temporary and Disability Assistance OR complete the enclosed application, sign it and return it to Sarah Herbert, WISCD – District Office, 321 List Avenue, Rochester, NY 14617 as soon as possible. Please refer to the guidelines contained in this letter when completing the application.

We cannot approve an application that is not complete, so be sure to fill out all required information.

• DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Use <u>one</u> Free and Reduced-Price School Meals Application for all students in your household. Complete the application to apply free or reduced-price meals. We cannot approve an application that is not complete, so be sure to fill out all required information. ## • WHO CAN GET FREE MEALS?

- 1. All children in households receiving benefits from Supplemental Nutrition Assistance Program (SNAP), the Food Distribution Program on Indian Reservations (FDPIR) or Temporary Assistance to Needy Families (TANF), are eligible for free meals. Categorical eligibility for free meal benefits is extended to all children in the household when the application lists an Assistance Program's case number for any household member. Also, your children can get free meals if your household's gross income is within the free limits on the Federal Income Eligibility Guidelines (listed on next page). Households with children who are categorically eligible through an Other Source Categorically Eligible designation, as defined by law, may be eligible for free benefits and should contact the SFA for assistance in receiving possible benefits.
- 2. Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
- 3. Children participating in their school's Head Start Program are eligible for free meals.
- 4. Children who meet the definition of homeless, runaway, or migrant are eligible for free meals. Households with children wo meet the definition of homeless, runaway, or migrant should contact the WICSD for assistance in receiving benefits.
- 5. Children may receive free meals if your household's GROSS income is within the free or reduced-price limits on the Federal Income Eligibility Guideline. Students in New York State that are approved for reduced priced meals will receive breakfast and lunch meals and snacks served through the Afterschool Snack Program at no charge.
- 6. Your children may qualify for free or reduced priced meals if your household's gross income fall at or below the limits on this chart:

- CAN FOSTER CHILDREN GET FREE MEALS? Yes, foster children who are under the legal responsibility of a foster care agency
  or court, are eligible for free meals. Any foster child in the household is eligible for free meals regardless of income. Foster children
  may also be included as a member of the foster family if the foster family chooses to also apply for benefits for other children. If
  non-foster children in a foster family are not eligible for free or reduced priced meals, an eligible foster child will still receive benefits.
  We require documentation from the county/state regarding guardianship of a foster child.
- CAN HOMELESS, RUNAWAY, AND MIGRANT CHILDREN GET FREE MEALS? Yes, children who meet the definition of homeless, runaway, or migrant qualify for free meals. If you haven't been told your children will get free meals, please call 585-336-3063 or write James Brennan, WISCD–District Office, 321 List Avenue, Rochester, NY 14617 to see if they qualify.
- WHO CAN GET REDUCED PRICE MEALS? Your children can get low-cost meals if your household income is within the reducedprice limits on the Federal Eligibility Income Chart, shown on this application.
- SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE APPROVED FREE MEALS? Please read the letter you got carefully and follow the instructions. Call Sarah Herbert at 585-336-3063 if you have questions.
- MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT ANOTHER ONE? Yes, your child's application is only good for that school year and for the first 30 days of this school year. You must send in a new application, <u>using the current school year application</u>, unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price of meals and you will be responsible for expenses incurred.
- I GET WIC. CAN MY CHILD(REN) GET FREE MEALS? Children in households participating in WIC may be eligible for free. or reduced-price meals. Please fill out a FREE/REDUCED PRICE MEAL application.
- WILL THE INFORMATION I GIVE BE CHECKED? Yes, and we may also ask you to send written proof.
- IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children
  with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income
  drops below the income limit.
- WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to Mr. James Brennan, 321 List Avenue, Rochester, NY 14617, 585-336-2993.
- MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You or your child(ren) do not have to be U.S. citizens to qualify for free or reduced-price meals.
- WHO SHOULD I INCLUDE AS MEMBERS OF MY HOUSEHOLD? You must include all people living in your household, related or not (such as grandparents, other relatives, or friends) who share income and expenses. You must include yourself and all children living with you. If you live with other people who are economically independent (for example, people who you do not support, who do not share income with you or your children, and who pay a pro-rated share of expenses), do not include them.
- WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you normally receive. For example, if you normally
  make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month.
  If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your
  hours or wages reduced, use your current income.
- WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
- MY FAMILY NEEDS MORE HELP. ARE THERE OTHER PROGRAMS WE MIGHT APPLY FOR? To find out how to apply for SNAP or other assistance benefits, contact your local assistance office or call 1-800-342-3009.

How to Apply: To get free or reduced-price meals for your children you may submit an Eligibility Letter for Free Meals received from the NYS Education Department, OR carefully complete **one application for your household** and return it to the designated office. All household member and children should be listed on one application.

 If you receive SNAP, Temporary Assistance to Needy Families (TANF) for any children or participate in the Food Distribution Program on Indian Reservations (FDPIR), the application must include the children's names, the household SNAP, TANF or FDPIR case number and the signature of an adult household member. Contact your local Department of Social Services for your SNAP or TANF case number, if necessary. No application is necessary if the household was notified by the School Food Authority that their children have been directly certified based on Assistance Program participation. If the household is not sure if ANY OR ALL of their children have been directly certified, the household should contact West Irondequoit CSD Food Service Office. If you do not list a SNAP, TANF or FDPIR case number for all the children for whom you are applying, the application must include the names of everyone in the household, the amount of income each household member, and how often it is received and where it comes from. It must include the signature of an adult household member and the last four digits of that adult's social security number or check the box if the adult does not have a social security number. <u>An application that is not complete cannot be approved.</u> Contact your local Department of Social Services for your SNAP or TANF case number or complete the income portion of the application. No application is necessary if the household was notified by the school that their children have been directly certified. If the household is not sure if their children have been directly certified, the household should contact the school.

**Reporting Changes**: The benefits that you are approved for at the time of application are effective for the entire school year and up to 30 operating days into the new school year (or until a new eligibility determination is made, whichever comes first). You no longer need to report changes for an increase in income or decrease in household size, or if you no longer receive SNAP.

<u>Meal Service to Children With Disabilities</u>: Federal regulations require schools and institutions to serve meals at no extra charge to children with a disability which may restrict their diet. A student with a disability is defined in 7CFR Part 15b.3 of federal regulations, as one who has a physical or mental impairment which substantially limits one or more major life activities of such individual, a record of such an impairment or being regarded as having such an impairment. Major life activities include, but are not limited to functions such as caring for oneself, performing manual tasks, seeing, hearing, eating, sleeping, walking, standing, lifting, bending, speaking, breathing, learning, reading, concentrating, thinking, communicating, and working. You must request meal modifications from the school and provide the school with medical statement from a State licensed healthcare professional. If you believe your child needs substitutions because of a disability, please get in touch with us for further information, as there is specific information that the medical certification must contain.

<u>Confidentiality</u>: The United States Department of Agriculture has approved the release of students names and eligibility status, without parent/guardian consent, to persons directly connected with the administration or enforcement of federal education programs such as Title I and the National Assessment of Educational Progress (NAEP), which are United States Department of Education programs used to determine areas such as the allocation of funds to schools, to evaluate socioeconomic status of the school's attendance area, and to assess educational progress. Information may also be released to State health or State education programs administered by the State agency or local education agency, provided the State or local education agency administers the program, and federal, State or local nutrition programs similar to the National School Lunch Program. Additionally, all information contained in the free and reduced price application may be released to persons directly connected with the administration or enforcement of programs authorized under the National School Lunch Act (NSLA) or Child Nutrition Act (CNA); including the National School Lunch and School Breakfast Programs, the Special Milk Program, the Child and Adult Care Food Program, Summer Food Service Program and the Special Supplemental Nutrition Program for Women Infants and Children (WIC); the Comptroller General of the United States for audit purposes, and federal, State or local law enforcement officials investigating alleged violation of the programs under the NSLA or CNA. The disclosure of eligibility information not specifically authorized by the NSLA requires a written consent statement from the parent/guardian.

**<u>Reapplication</u>**: You may apply for benefits any time during the school year. Also, if you are not eligible now, but during the school year become unemployed, have a decrease in household income, or an increase in family size, you may request and complete an application with proof of income, at that time.

## FREE AND REDUCED-PRICE MEAL APPLICATION FACT SHEET

### When filling out the application form, please pay careful attention to these helpful hints.

**<u>SNAP/TANF/FDPIR case number</u>**: This must be the <u>complete</u> valid case number supplied to you by the agency including all numbers <u>and</u> letters, for example, E 123456, or whatever combination is used in your county. Refer to a letter you received from your local Department of Social Services for your case number or contact them for your number.

**Foster Child:** A child who is living with a family but who is under the legal care of the welfare agency or court may be listed on your family application. List the child's "personal use" income. This includes only those funds provided by the agency which are identified for the <u>personal</u> use of the child, such as personal spending allowances, money received by his/her family, or from a job. Funds provided for housing, food and care, medical, and therapeutic needs are <u>not</u> considered income to the foster child. Write "0" if the child has no personal use income.

Household: A group of related or non-related people who are living in one house and share income and expenses.

Adult Family Members: All related and non-related people who are 21 years of age and older living in your house.

<u>Financially Independent</u>: A person is financially independent and a separate economic unit/household when his or her earnings and expenses are not shared by the family/household. Separate economic units in the same residence are characterized by prorating expenses and by economic independent from one another.

<u>Current Gross Income</u>: Money earned or received at the present time by each member of your household <u>before deductions</u>. Examples of deductions are federal tax, State tax, and Social Security deductions. If you have more than one job, you must list the income from all sources. If you receive income from more than one source (wage, alimony, child support, etc.), you must list the income from ALL sources. Only farmers, self-employed workers, migrant workers, and other seasonal employees may use their income for the past 12 months reported from their 1040 Tax Forms.

Examples of gross income are:

- · Wages, salaries, tips, commissions, or income from self-employment
- Net farm income gross sales minus expenses only not losses
- Pensions, annuities, or other retirement income including Social Security retirement benefits.
- Unemployment compensation
- Welfare payments (does not include value of SNAP)
- Public Assistance payments
- Adoption assistance
- Supplemental Security Income (SSI) or Social Security Survivor's Benefits
- Alimony or child support payments
- Disability benefits, including workman's compensation.
- Veteran's subsistence benefits
- Interest or dividend income
- Cash withdrawn from savings, investments, trusts, and other resources which would be available to pay for a child's meals.
- Other cash income

<u>Income Exclusions</u>: The value of any childcare provided or arranged, or any amount received as payment for such childcare or reimbursement for costs incurred for such care under the Child Care Development (Block Grant) Fund should not be considered as income for this program.

### 2023-2024 APPLICATION INSTRUCTIONS

To apply for free and reduced-price meals, submit a Free Meals/Milk Eligibility Letter received from the Office of Temporary and Disability Assistance OR complete only one application for your household using the instructions. Sign the application and return the application to Sarah Herbert, WICSD District Office, 321 List Avenue, Rochester, NY 14617. If you have a foster child in your household, you may include them on your application. A separate application is no longer needed. Call Sarah Herbert, Free and Reduced Meal Coordinator, at (585) 336-3063 if you need help.

#### PART 1 ALL HOUSEHOLDS MUST COMPLETE STUDENT INFORMATION. <u>DO NOT FILL OUT MORE THAN ONE APPLICATION FOR YOUR</u> HOUSEHOLD.

- (1) Print the names of the children, including foster children, for whom you are applying on one application.
- (2) List their grade and school.
- (3) Check the box to indicate a foster child living in your household, or if you believe any child meets the description for homeless,
  - migrant, runaway (school staff will confirm this eligibility).

#### PART 2 HOUSEHOLDS GETTING FOOD STAMPS (SNAP), TANF OR FDPIR SHOULD COMPLETE PART 2 AND SIGN PART 4.

(1) List a current Food Stamp, TANF or FDPIR (Food Distribution Program on Indian Reservations) case number of anyone living in your household.

#### Do not use the 16-digit number on your benefit card. The case number is provided on your benefit letter.

(2) An adult household member must sign the application in PART 4. SKIP PART 3. Do not list names of household members or income if you list a food stamp case number, TANF or FDPIR number.

#### PART 3 ALL OTHER HOUSEHOLDS MUST COMPLETE THESE PARTS AND ALL OF PART 4.

- (1) Write the names of everyone in your household, whether or not they get income. Include yourself, the children you are applying for, all other children, your spouse, grandparents, and other related and unrelated people in your household. Use another piece of paper if you need more space.
- (2) Write the amount of current income each household member receives, before taxes or anything else is taken out, and indicate where it came from, such as earnings, welfare, pensions, and other income. If the current income was more or less than usual, write that person's usual income. Specify how often this income amount is received: weekly, every other week (bi-weekly), 2 x per month, monthly. If no income, check the box. The value of any childcare provided or arranged, or any amount received as payment for such childcare or reimbursement for costs incurred for such care under the Child Care and Development Block Grant, TANF and At-Risk Child-Care Programs should not be considered as income for this program.
- (3) Enter the total number of household members in the box provided. The number should include all adults and children in the household and should reflect the members listed in PART 1 and PART 3.
- (4) The application must include the last four digits only of the social security number of the adult who signs PART 4 if Part 3 is completed. If the adult does not have a social security number, check the box. If you listed a food stamp (SNAP), TANF or FDPIR number, a social security number is not needed.
- (5) The adult household member must sign the application in PART 4.

**OTHER BENEFITS:** Your child may be eligible for benefits such as Medicaid or Children's Health Insurance Program (CHIP). To determine if your child is eligible, program officials need information from your free and reduced-price meal application. Your written consent is required before any information may be released. Please refer to the attached parent Disclosure Letter and Consent Statement for information about other benefits.

#### USE OF INFORMATION STATEMENT

Use of Information Statement: The Richard B. Russell National School Lunch Act requires the information on this application. You do not have to give the information, but if you do not submit all needed information, we cannot approve your child for free or reduced-price meals. You must include the last four digits of the social security number of the primary wage earner or of the adult household member who signs the application. The last four digits of the social security number are not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistant Program (SNAP), Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced-price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.
